Welcoming all the participants, Hon'ble Minister, Revenue Department initiated the agenda wise discussion. The issues discussed in the meeting and the decisions taken in the meeting are given below :

1. ALLOTMENT OF LAND :

- (i) DM, West reported that 2047 cases are under process for identification of BPL bothless families and 309 proposal sent to Revenue Department. It was decided that all cases to be completed by December, 2015.
- (ii) DM, Sepahijala reported that in the 2nd week of October, 2015 all pending cases will be completed.
- (iii) DM, South reported that in total 209 cases are initiated and Allotment Committee meeting will be organized for the purpose in the month of October, 2015.
- (iv) DM, Unakoti reported that 12 nos of bothless, 350 landless and 22 homeless families have been identified. 80 cases are under process for allotment out of which 45 cases approved for allotment.
- (v) DM, Khowai reported that 880 cases initiated for allotment and 337 proposals sent to Revenue Department for NOC in respect of BPL bothless families. In respect of BPL homeless families, 186 proposals are initiated, 138 approved by SDLAC, among those 73 are completed.
- (vi) In North Tripura, 176 cases completed out of 462 BPL families and 114 cases initiated for allotment and 13 cases sent to Revenue Department for approval.
- (vii) In Gomati District, 346 cases are initiated for BPL bothless families, among those 187 are completed and 332 homeless families are under process for allotment among those 271 cases are completed.
- (viii) DM, Dhalai reported that out of 501 BPL bothless families, 211 cases have been initiated. All the DM & Collectors have been instructed to complete all cases as per available information by 15th December, 2015 and are also instructed to check & verify the Land Pass book regularly. The DM & Collectors have been instructed to verify the unauthorized occupation on the Khas land in respective areas. The statistics provided regarding left out bothless, homelss & landless BPL families are to be reviewed.

(Action : All DM & Collector, Revenue Department)

2. BADP :

- (i) All DM & Collectors have been requested to submit all pending UCs in respect of the projects of 2013-14 by end September, 2015 and of 2014-15 by October, 2015 and if required, reconciliation of the UCs be made with the BADP section of Revenue Department.
- (ii) DM & Collectors have also been requested to upload the photographs of all completed projects on the District Website regularly.
- (iii) 1st installment of BADP funds for 2015-16 has been placed with DMs. This fund be first used to provide balance funds works sanctioned under BADP in 2014-15 and then, the rest for new projects of current year.
- (iv) Annual Action Plan (AAP) 2015-16 must be uploaded on MIS Application by all border blocks immediately.
