

MINUTES OF THE MONTHLY REVENUE MEETING HELD ON 20TH MARCH AT 3.00 P.M. IN THE CHAMBER OF THE ADDL. DISTRICT MAGISTRATE & COLLECTOR, WEST TRIPURA.

The meeting was chaired by Sri S.Nama, Addl. District Magistrate & Collector, West Tripura District.

After detailed discussion, the following decisions were taken.

1] Allotment of khas land to BPL Bothless & Homeless families.

- a) Allotment of land to the Individual BPL, Bothless & Homeless families almost completed.
- b) ROR/Khatian may be opened in respect of allotment given without premium immediately and on receipt of 1st installment of premium from allottee in respect of allotment given with premium.
- c) Balance premium may be realized from time to time. If any allottee fails to pay the premium, notice may be issued.
- d) Process for allotment of land shall be continuing.
- e) Proposal for re-constitution of the Sub-Divisional Land Allotment Committee (Official & Non-Official member) shall be sent to this office within a week for conveying approval of the Government.

(Action- SDM- SDR/JRN/MNP).

2] Departmental Allotment of land.

- a) Maximum allotment proposals under Sadar Sub-Division are pending due to non-availability of Government khas land. The SDM, Sadar has been requested to hold a meeting with the representative of requiring Department and ask them to show land of their choice or to inform whether they are agreed to acquire Jote land.
(Action-SDM, Sadar).
- (b) The SDM, Jirania is requested to take necessary steps for sending the proposal in respect of Fertilizer Godown, Food Godown near NIT, Addl. Land for NIT near Muslim para etc.
- (c) The SDM, Mohanpur is also requested to send the proposal in respect of Dumping Ground, Addl. Land for IIIT, Forest Ranger Office etc.
- d) Records to be up-dated immediately whenever any allotment/acquisition is made.

(Action- SDM, Sadar/Jirania/Mohanpur)

3] CLR/NLRMP.

- a) All SDMs are once again requested to find out the khatians which are not authenticated in different moujas under West District due to technical error and send all relevant land records/papers to the office of the DSLR directly for solution of the problems.
