

MINUTES OF THE DISTRICT LEVEL REVIEW MEETING HELD ON 11.03.2015 AT 10.30 AM IN THE CONFERENCE HALL OF DM & COLLECTOR WEST TRIPURA DISTRICT UNDER THE CHAIRMANSHIP OF DM & COLLECTOR WEST TRIPURA DISTRICT.

At the very outset of the meeting the District Magistrate & Collector welcomed all District Level Officers, BDOs and other officials of line department and Bankers present in the meeting. Agenda wise discussion was started with respective officers on **MGNREGA, IAY, Sanitation, Drinking Water, Power Connectivity, Road Connectivity, Irrigation, Agriculture, Horticulture, ARDD, Fisheries, Education (School) and Health & Family Welfare departments, Horticulture, IWMP, Sericulture, ADC, PMJDY, PTZP, Tribal Welfare, Tripura Bamboo Mission**, and the following decisions have been taken.

MGNREGA:

1. From the year 2015-16 the line departments will take up comprehensive project by converging departmental fund with MGNREGA fund in selected GP/Village. The line departments have been requested to study the land availability in GP/Villages and select project in advance for successful implementation. **(Action by all Line Departments)**
2. It is reported by BDOs that their MGNREGA workers are facing problem in getting payment of wages from the TGB & TSCB Bank Branches. The District Authority of TGB, TSCB & LDM has been requested to look into the matter personally and ensure the payment of wages within 15 days after completion of work. Any deviation in this regard will be dealt with in preview of MGNREGA Act. **(Action by BDOs & TGB, TSCB and LDM)**
3. Line department and Blocks have not refunded all the fund to SBI TLA Branch till date. All BDOs and Line Department are requested to refund the unspent balance amount to the SBI TLA Branch, Agartala and complete the MIS entry by 15th March 2015. Line department and BDOs are requested to submit updated 0 (zero) balance last page of MGNREGA account bank pass book with in 20th March 2015. **(Action by all Line Departments & BDOs)**
4. Online transfer of an amount of Rs. 1.57 lakh is not completed till date by TTADC. DM & Collector West Tripura instructed to come with one operation at DM Office with pass word and done by today. **(Action by ZDO, TTADC)**
5. DSC is pending in Water Resource Department 1 no, ARDD Department Mohanpur 1 nos, Jirania R.D.Block 1 no. DM & Collector West Tripura request O/C Dev will coordinate for getting the pending DSC by 20th March 2015. **(Action by EE WR & Dy. Director ARDD & O/C Dev)**
6. BDOs are requested to complete block wise target of person days by 28th March 2015 & detailed report should be kept in register with justification for delay payment. **(Action by all BDOs)**
