DECLARATION

WHEREAS, it was Notified by Government in the Revenue Department vide Notification **NO. F. 09 (02)-REV/ACQ/VI/16** dated 03-07-2017, that the land/ lands described in the schedule hereto (hereafter referred to as the said land / lands) was / were needed or likely to be needed for the public purpose, namely for the purpose of **setting up of Railfed Pol Storage Depot at near Sekerkote** under Sadar Sub-Division in West Tripura District;

AND WHEREAS, the Rehabilitation and Resettlement Scheme was approved by the appropriate Authority and published as per provision of **Section 18** of the "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013". A summary of the said Scheme is given as "ANNEXURE-A".

AND WHEREAS, the Requiring Body has deposited the cost of land to be acquired with the Collector;

NOW, THEREFORE, it is hereby Declared under the Provision of **Section 19** of the Land Acquisition & Rehabilitation Act that the said land / lands is / are required for the public purpose, namely for the purpose of **setting up of Railfed Pol Storage Depot at near Sekerkote** under Sadar Sub-Division in West Tripura District.

The Government is also pleased to direct the Collector West Tripura District under **Section 20** of the said Act to proceed with the works.

The Land Statement and Plan may be inspected in the Office of the Collector, West Tripura District during office hours.
