
Sir,

I am directed to refer to your letter No. 5053/F. DM/W/LA/SDR/14/2013 dated 04-11-2017 on the above noted subject wherein, it was requested from your end to accord final decision of the Government on the proposed acquisition in pursuance of the Rule 3 (10) of the RFCTLARR Rules, 2015.

2. In this connection, it is also to inform you that the Government in Revenue Department has examined your proposal along with the evaluation report of the Expert Group on Social Impact Assessment Study in connection with the above mentioned acquisition process and after examination of all the reports, the same has been recommended by the Government as per provision of U/S-8 (2) of the RFCTLARR Act, 2013.

3. In this regard, I am further directed to request you kindly to take necessary steps for acquisition of land by the State Government to acquire land as per recommendation of the Expert Group in pursuance of the provision U/S- 8 (3) of the RFCTLARR Act, 2013. Thereafter, after making all formalities, proposal for issuing of Notification U/S-11 (1) of the new L. A. Act may be initiated.

4. This is for your kind information and taking necessary action on the issue.



Subject:- **Evaluation by the Expert Group over the report of Social Impact Assessment Study** as conducted by the SIA Team members in connection with acquisition of land measuring **0.4530** acres for up-gradation of road from Central Road Extension to Bye Pass road via Madhya Pratapgarh & Dukli Bazar (Jewels Club to Bye Pass road portion) at mouja Dukli, Sheet No: **1(2)P**.

As per recommendation of the Revenue Department, Government of Tripura vide Notification No.F.09(04)-REV/ACQ/VI/2014 dated 10/10/2017, we the undersigned examined the SIA report as submitted by SIA team in the prescribed format in connection with the proposal for acquisition of land measuring **0.4530** acres for up-gradation of road from Central Road Extension to Bye Pass road via Madhya Pratapgarh & Dukli Bazar (Jewels Club to Bye Pass road portion) at mouja Dukli Sheet No. 1(2)P. The observations in respect of the SIA report are hereby mentioned below:-

- a) The proposed project is exclusively legitimate & bonafide for public purpose and optimum level of public interest will be served with the setting up of the project.
- b) The land measuring 0.4530 acres of mouja Dukli, Sheet No. 1(2)P for acquisition of land for up-gradation of road from Central Road Extension to Bye Pass road via Madhya Pratapgarh & Dukli Bazar (Jewels Club to Bye Pass road portion) appears to be minimum quantum of land required for the said purpose.
- c) There is no unutilized land in the previously acquired area and the proposed land to be acquired is very much contiguous to the existing road. As such, there is no alternative proposal.
- d) The potential benefit of the acquisition shall outweigh the social cost and adverse social impact as determined by the SIA members.
