WHEREAS, the land is within the jurisdiction of Gram Panchayet/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation, the members of Gram Sabha/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation may give consent/approval to the proposed project.

WHEREAS, the concerned land owner Shri/Smti. (as per list enclosed) himself/herself or his/her representative may remain present for hearing for consent/approval for the project.
