**NOTIFICATION**

WHEREAS, acquisition of land area measuring 2.650 acres in R. S. Plot No/Nos. 4241, 4248, 4247, 4246, 4245, 4244, 4243, 4234, 4237/11414, 4239, 4234/11406, 4239/11405, 4251, 4234/11392, 4239/11393, 4234/11400, 4239/11399, 4228, 4231, 4242, 4237, 4238 & 4251/9714/P, Class Nal, Pukurpar (Nal), Viti (Nal), & Pukur (Nal), in Khatian No/Nos. 1263/1, 1263/1, 5, 1263/1, 4, 1263/1, 7, 5151, 5142, 5130, 5138, 4608 & 2822/1, 3, under Ramnagar Sheet No. 2/P Mouja of Ramnagar Tehsil under Sadar Sub-Division for the purpose of development of Integrated Check Post (ICP), Agartala to be constructed/developed by the Director, Land Port Authority of India, Lok Nayak Bhawan, 1<sup>st</sup> Floor, Khan Market, New Delhi is/are proposed.

Complex, Agartala-Member, (ix) SDPO, Amtali, West Tripura District-Member, (x) CDPO, Dukli, Sadar Sub-Division-Member, (xi) Shri Debasish Nandi, Manager, LPAI, ICP Complex, Agartala-Member & (xii) Shri Bimal Deb Barma, Surveyor, DM's Office, West Tripura District-Member has/have been formed to consult, to survey and to take public hearing after publication of this Notification.

WHEREAS, the aforesaid team will conduct hearing on 21-10-2016 at 11.30 A. M. at Ramnagar TK Office, on which all concerned are requested to remain present with their claims/objections/suggestions, if any.

WHEREAS, the land is within the jurisdiction of Gram Panchayet/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation, the members of Gram Sabha/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation may give consent/approval to the proposed project.

THE concerned land owner as specified at "Annexure-A" himself/herself or his/her representative may remain present for hearing for consent/approval for the project.

THE process must be completed and SIA report must be submitted along with the plan (SIMP) within the time specified in the Rule 3.

ANY attempt at coercion or threat against the process during the specified period will render the exercise null & void.
