NOTIFICATION

WHEREAS, acquisition of land area measuring 0.4530 acres in R. S. Plot No/Nos. as specified at "Annexure-A", Class as specified at "Annexure-A", in Khatian No/Nos. as specified at "Annexure-A", under Dukli Sheet No. 1 (2)/P Mouja of Dukli Tehsil under Sadar Sub-Division for the purpose of up-gradation of road from Central Road Extension via Madhya Pratapgarh & Dukli Bazar (Jewels Club to Bye Pass road portion) to be constructed/developed by the Executive Engineer, PWD (R & B), Agartala Division No. V, Agartala is/are proposed.

Nagar-Member & (xiii) Shri Debananda Deb Barma, Surveyor, DM's Office, West Tripura District-Member has/have been formed to consult, to survey and to take public hearing after publication of this Notification.

WHEREAS, the aforesaid team will conduct hearing on 04-04-2017 at 11.30 A. M. at Dukli T. K. Office, on which all concerned are requested to remain present with their claims/objections/suggestions, if any.

WHEREAS, the land is within the jurisdiction of Gram Panchayet/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation, the members of Gram Sabha/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation may give consent/approval to the proposed project.

THE concerned land owner as specified at "Annexure-A" himself/herself or his/her representative may remain present for hearing for consent/approval for the project.

THE process must be completed and SIA report must be submitted along with the plan (SIMP) within the time specified in the Rule 3.

ANY attempt at coercion or threat against the process during the specified period will render the exercise null & void.


